Dear Sir:

On April 12th I wrote you that, since your name could not be found on file in the War Department as having served in Company A, 1st (Forrest's) Tennessee Cavalry, it would be necessary for you to furnish me with two good affidavits from comrades before I could grant your claim for pension. On June 4th I again wrote you telling you that I had written a second time to the War Department, and would advise you on receipt of a reply. I now have this reply and regret to say that it does not clear up the matter for you. Below is a copy of the reply:-

"The name David M. Haston has not been found on the rolls on file in this office of any Confederate States Army organization. If the given names of the officers be furnished a further search of the records will be made. William T. York was Captain of Company A, 1st Regiment Georgia Cavalry, and D. W. Horton served as a Private in this company. O. J. York was Captain of Company A, 13th (Gore's) Regiment Tennessee Cavalry, C. S. A. Both of these organizations served in Forrest's Brigade."

If you served from 1862 to 1865 it seems that your name should appear on the roll, and since it does not the matter of your pension remains as before - two good affidavits required before claim can be granted. I am inclosing more blanks and trust you will have success in locating two comrades.

When the reply comes I will advise you immediately, but I very much fear we will find nothing more than we did at first. I sent you a copy of the word we got from Washington, in my letter to you of last April 12th.

If I were you I would keep on hunting for old comrades. Did you try the plan of advertising in The "Confederate Veteran," as I suggested in my former letter to you? In the meantime we will all keep hoping that proof of your service may be found some way.

It is with regret I have to advise that there is no service record on file for you in the War Department, which fact will make it necessary for you to furnish me with two good affidavits from comrades who served in the same command with you and who have personal knowledge of your service before I can grant your claim for pension. If I were you I would advertise for such comrades in "The Confederate Veteran," published at Nashville, Tenn. A good many of our applicants have done this, with good results. It might pay you to make every effort to locate men who could help you in this matter of a pension. Ever so many of our pensioners have had to prove their service by affidavit, and some of their comrades are still living why shouldn't some yours be, also?
